Treasurer's Report

I am pleased to report that the Trust had an operating surplus at the end of March 2007 in spite of increased costs in maintaining the building.

The main grant continues to be the Supporting People Grant but in line with Government policy this is a static amount and does not allow for inflation. The Trust was pleased to receive again this year a grant from the London Borough of Lewisham Community sector, which enabled the organisation to provide services and support not covered by the core funding. We are also grateful to receive grants from the Goldsmiths money, the Hilden Trust, the Lee Charity of William Hatcliffe, and the regular contribution from Mr Goss and Ms Drysdale, all of which has been spent on the continuation of the Education Project. Donations and the fundraising activities of the Friends of Marsha Phoenix have increased the size of the Education Fund, enabling more young women to further their education.



Director's Report

This is now my 5th year as Director and the role continues to present me with plenty of challenges and work which can be as varied day to day from unblocking the toilet to managing our finances! Yet more and varied monitoring requirements and reports have been asked of us this year and we have met these challenges as they arose; we have achieved a new "House in Multiple Occupation Licence" and implemented a new Food Safety standard. We replaced our (functioning) old central heating boilers with something modern and less effective (!) safe in the knowledge that we continue fully CORGI compliant.

The Supporting People system continues to throw up more challenges for us to meet in terms of monitoring and keeping abreast of changes to the regime. I think I am right in reporting that we have not been late for a single deadline for any report due to Supporting People, London Borough of Lewisham community Sector team, London and Quadrant or to our other funders and supporters all year long. Financially we have continued to maximise our income by having practically no void periods and low rent arrears. We have been able to stretch our food budget further by signing up with the excellent service of "Fareshare" which enables us to obtain excess quality food from supermarkets and other sources for our residents on a regular basis.

The staff team has continued as reliably as ever and we have varied some roles by taking advantage of Althea Gayle's maternity leave to allow for some in-house cover.

We have continued to try to continue to invest in our staff by maximising training and development opportunities with some 60 training courses and activities amongst 14 staff being undertaken throughout the year.

I particularly congratulate Chris Hunt who achieved her doctorate in counselling psychology this year, all in her own time. She is now Dr. Hunt and should give herself a well-deserved pat on the back for this achievement.

Resident satisfaction with the service in general has remained high, and we continue to seek ways of meeting needs in as many ways as possible. This might vary from helping someone with her university application to showing someone else how to operate a washing machine, and staff have to be flexible enough to make meeting these needs “all in a days work”, giving equal attention to everyone. Year one of our business plan commenced in April 2006 and progress towards our goals has been good, and even though external forces might change our focus, our core objectives have remained intact.

Last but not least, 2007 saw the 80th birthday of our founder and mainstay Sybil Phoenix, whom we wholeheartedly congratulate on reaching this milestone so successfully and with such style. We look forward to her 90th.

Staff Reports

Health and Safety is always a major part of Marsha Phoenix Memorial Trust, because we provide accommodation on a 24-hour basis, which entails ensuring the safety of everyone in the House at all times.

We do regular spot checks when there are enough staff on shift. This allows us to know both the Trust and residents are adhering to the health and safety procedures. We also survey new residents to ensure they have a full knowledge of all the health and safety procedures as explained to them when they moved in. The Fire Brigade made one of their periodic unannounced visits one Sunday in February and we were given an excellent commendation for our record keeping and procedures. This is down to the fact that Marsha Phoenix Memorial Trust's staff and residents adhere to the procedures that are in place. We have had some new challenges to meet this year and most recently put in place measures to respond to the smoking ban in what is both a home and a workplace. The two six-monthly risk assessments were completed on time as usual during the year and I say well done to everyone that assists in carrying these out.

Report from the Executive Committee

I am delighted to report the Marsha Phoenix Memorial Trust Executive Committee continues to oversee the management of the Trust, which includes the Tressillian Road and Erlanger Road buildings. Both are “home from home” houses looking after the needs of young women by housing, supporting, advising and educating them.

The executive management committee volunteers come from diverse backgrounds bringing invaluable knowledge, experience, expertise and professionalism to the Trust. This year the executive committee and the staffing sub committee on which I also serve carried out the following:

- A Committee Skills Audit
- Committee skills training
- Training with staff of Marsha Phoenix Memorial Trust
- Approved education grants
- Approved repair and maintenance for both buildings
- Reviewed and strengthened personnel procedures
- Approved new counselling and support services for staff
- Continued to oversee the budget of the Trust
- Supported the Friends of Marsha Phoenix Memorial Trust in fund raising activities

2007 has been a special year for the executive committee, which continues to grow from strength to strength, ensuring the Trust is



fit for the 21st Century and ready to meet new challenges and requirements, such as updated Supporting People Requirements and Houses in Multiple Occupation Legislation.

This year is also poignant, commemorating the abolition of the Transatlantic Slave Trade, 1807–2007. Executive committee members visited the House of Parliament’s exhibition which looked at the background to the abolition of the British Slave Trade. It examined the pressures from home and abroad which influenced Parliament, and eventually led to the Act to abolish Britain’s slave trade in 1807. However, history tells us, this continued for sometime afterwards and sadly still exists to a degree today. We also pay grateful tribute to Mrs Sybil Phoenix MBE, MS, founder of the Marsha Phoenix Memorial Trust. She celebrated her 80th birthday with a “special surprise birthday party” in Lewisham’s Theatre and a thanksgiving church service and lunch. Mrs Phoenix continues to be the backbone of the Trust and works tirelessly to support the community here and abroad.

Education and Resettlement Reports

Resettlement

The challenge of resettlement continued to fox us during this year, sometimes in unforeseen ways; new arrangements within the council have meant a lot of our mainstays for onward referral had to shift how they allocate their vacancies, plus move on to permanent housing continued as a challenge. In spite of this we managed to move on 22 people, two more than last year, with 14 going to permanent housing and seven to second stage projects.

This was achieved thanks to co-operation from the Housing Options Centre over six statutorily homeless cases to permanent move on, and from the strategic rehousing team and the Homeseach team who helped us to achieve our move on quota during the last quarter of the year. We calculated that the average stay at the main hostel was 16 months, which we are very satisfied with. Stays at Erlanger Rd averaged 29 months due to the aforementioned move on delays which are now resolved. All this enabled us to start the New Year with new residents and with some long standing people moving into their long awaited independent home. We surveyed those who had moved as usual and found the majority still housed and happy at the year end.

Thanks to St Christopher's, Stopover, Community Housing, Ekaya and King's Church centre for helping with move on over the year. Thanks as usual to Jane Ferneyhough and the borough for the move on quota and to London and Quadrant for honouring their quota to us as well. All this help has been much appreciated by us and more importantly by those we seek to house.

Again we thank the Morph housing project in Camberwell, which provides a valuable source of low cost furniture. Also to the Lee charity of William Hatcliffe who provided a move on grant to three hard working ex Erlanger Rd residents setting up home for the first time. We thank Community Housing and London and Quadrant for providing ongoing floating support when the need arose.

Social Events, Education and Welfare

Funding from the Goldsmiths Company and the Hilden foundation meant the Education coordinator continued her valuable work. We are also grateful for the private donations of Ben and Jane Goss. Their monthly payments have provided a funding stream for this project

which has been invaluable to us and which we have been able to maximise by use of Gift Aid. We thank the Lee charity of William Hatcliffe for committing to help with this funding from 2007 and for the next two years to come.

Ethel attends the project every week and is always in demand to give some time to any number of young women wishing to use her expertise and mentoring to realise their educational goals. We thank Lewisham College for our excellent tutors, allowing us to offer activities which are both educational and fun throughout the year. In terms of “extras” our make up class run by Maxine of Nu Woman Beauty was especially popular. Testimony to this lies in the photographs shown elsewhere of our beautiful young ladies having fully utilised this class! We also ran an extra English Summer class, dance classes and some self-development classes run by our excellent and talented new partner and local author Esther Austin of www.emotionsintransit.co.uk.

Meanwhile our Education access fund has continued to grow and we have supported a number of young women over the year with rent, books and equipment. We can report that all those who we have helped at university are still studying and making a success of this opportunity. We thank Citibank, HSBC, Juliet Johnson and all at Thomas Ford and partners, The British and Foreign School Society, Bridget Hannigan and Analysis Mason Group, all for donations to the Fund which mean we can continue with this work. We extend our thanks to the London Borough of Lewisham Community sector unit for their contribution to our education work as well as to our cook and food provision. Their invaluable contribution also allows us to organise trips and outings and to support our counsellors, Chris and Sam, whose in house counselling service continues to be a popular and necessary part of the support we are able to offer our residents.

As usual we had plenty of trips during the year, to the theatre and cinema and out for meals. Our summer trip was to Thorpe Park, where Mrs P put us all to shame by going on all the fastest and most terrifying rides on offer. We had another lovely Christmas dinner, which has become a regular annual feature due to its popularity with staff and residents alike.
